

CHEEZ-IT™ FLOOR SEAT GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Cheez-It™ Floor Seat Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 7/21/24 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 7/23/24 at 11:59:59 PM (ET) (the “**Promotion Period**”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “like” the Sweepstakes post by the **Cheez-It®** Instagram account (**@cheezit**) posted on 7/21/24; comment on it using the Hashtag and tag a friend (as defined below); and follow the **Cheez-It®** Instagram account (**@cheezit**) on Instagram (the “**Submission**”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“**Sponsor**”), which shall be final and binding in all respects.

2. **ELIGIBILITY:** Sweepstakes is open only to legal residents of the state of Indiana who are eighteen (18) years of age or older at time of entry. Submission must be completed from the entrant’s non-private Instagram account; you must “like” the Sweepstakes post by **@cheezit** posted on 7/21/24; you must comment on it with the Hashtag and tag a friend; and you must follow **@cheezit** on

Instagram for your Submission to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to enter. Instagram account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Instagram. Limit one (1) entry per person/account for the Promotion Period.

Each Submission must meet the following “**Submission Requirements**” (any Submission that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Submissions must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;
- Entrant must be the rightful owner of the Instagram account associated with the Submission;
- Submission must comply with Instagram’s terms and conditions as posted on its platform;

4. **WINNER SELECTION AND NOTIFICATION:** One (1) Grand Prize winner will be randomly selected from all eligible entries received during the Promotion Period on or about 7/24/24 by Sponsor or its designee, whose decisions are final. The potential winner will be the entrant of the Submission that is associated with the

entry that is randomly selected as a winning entry, subject to eligibility verification. Potential winner will be notified via direct message within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Grand Prize consists of two (2) floor side tickets to the Indiana Fever 2024 regular season home game scheduled for 8/16/24 (total ARV of prize \$440). Winner will receive the tickets via email from Ticketmaster. **Transportation to-from the game and any other expenses related to the prize are not included and are the sole responsibility of the winner.** In the event the scheduled game associated with the prize and/or any other component of the prize is cancelled, delayed, or postponed for any reason outside the control of the Sponsor, Sponsor will have no further obligation, other than to award the remainder of the prize.
