### OFFICIAL RULES

1. **PROMOTION DESCRIPTION.** The **Cheez-It™ Free Cheez-It™ Sweepstakes** (the "**Sweepstakes**") is an online entry only Sweepstakes that begins on 3/14/25 at 12:00:00 AM Eastern Time ("**ET**") and ends on 4/29/25 at 11:59:59 PM (ET) (the "**Promotion Period**").
