

CHEEZ-IT™ HALLOWEEN GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Cheez-It™ Halloween Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 10/23/23 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 10/25/23 at 11:59:59 PM (ET) (the “**Promotion Period**”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “like” a post by the **Cheez-It®** Instagram account (**@cheezit**) or the **Smarties®** Instagram account (**@smarties**); post a comment using a cheese emoji and a candy emoji and the Hashtag and tag a friend (as defined below) on Instagram in response to the Sweepstakes post on 10/23/23 by **@cheezit** or **@smarties** (the “**Submission**”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“**Sponsor**”), which shall be final and binding in all respects.

Submission must be completed from the entrant’s non-private Instagram account; you must “like” the Sweepstakes post made by **@cheezit** or **@smarties** on 10/23/23; you must comment on the Sweepstakes post using a cheese emoji, a candy emoji and the Hashtag and tag a friend; and you must follow **@cheezit** and **@smarties** for your Submission to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to enter. Instagram account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Instagram. Limit of five (5) entries per person for the Promotion Period.

Each Submission must meet the following **“Submission Requirements”** (any Submission that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Submissions must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;
- Entrant must be the rightful owner of the Instagram account associated with the Submission;
- Submission must comply with Instagram’s terms and conditions as posted on its platform;

The potential winner will be the entrant of the Submission that is associated with the entry that is randomly selected as a winning entry, subject to eligibility verification. Potential winner will be notified via direct message within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by

the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected.
