

CHEEZ-IT™ X BOCCE'S BAKERY GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Cheez-It™ x Bocce's Bakery Giveaway** (the "**Sweepstakes**") is a social media Sweepstakes that begins on 4/2/24 at 12:00:00 AM Eastern Time ("**ET**") and ends on 4/3/24 at 11:59:59 PM (ET) (the "**Promotion Period**").

Throughout the Promotion Period, eligible entrants will have the opportunity to "like" the Sweepstakes post by the **Cheez-It®** Instagram account (**@cheezit**) on 4/2/24; comment on it using the Hashtag and tag a friend (as defined below); and follow the **Cheez-It®** Instagram account (**@cheezit**) and the **Bocce's Bakery** Instagram account (**@bocesbakery**) on Instagram (the "**Submission**"), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova ("**Sponsor**"), which shall be final and binding in all respects.
