OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Cheez-It™ x Mom® Water Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 11/10/25 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 11/14/25 at 11:59:59 PM (ET) (the “**Promotion Period**”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “like” the Sweepstakes post by the **Cheez-It®** Instagram account (**@cheezit**) on 11/10/25; comment on it using the Hashtag (as defined below) and tag a friend (as described below); and follow the **Cheez-It®** Instagram account (**@cheezit**) and the **Mom® Water** Instagram account (**@drinkmomwater**) on Instagram (the “**Submission**”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period from all eligible Submissions.

By participating in the Sweepstakes and completing a Submission (as more fully set forth below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“**Sponsor**”), which shall be final and binding in all respects.

Potential winner will be notified via direct message within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by the potential winner for any reason.
